Unfortunately your title page and headers are not done according to Ashford's APA guidelines. I suggest using the APA template to get your title page, headers, and page numbers correctly formatted. - 4. APA citations Citing sources An in-text citation should include the author's last name, the year, and if citing a direct quote, a page number. (Author, year, p. #). If no author is provided, you would have the title of the piece instead: ("Title of article," year). If no year is provided, you will include n.d. for no date: (Author, n.d.). If no page numbers are provided, you will use the paragraph number: (Author, year, para. #).

Here are two ways that you can set up a citation, which works for quoting or for summarizing and paraphrasing:

- a. As LastName (year) states, "quote" or paraphrase (p.#).
- b. "Quote" or paraphrase (LastName, Year, p.#).

This article articulates that thousands and thousands of Syrian refugees who are registered by the UN High Commissioner for Refugees (UNHCR) live in Lebanon. According to Refaat and Mohanna (2013) this had lead to an increase of the Lebanon's population by over 25% (p. 763). Unfortunately, just as expected, the living conditions of the homeless refugees are pathetic. Despite the fact that



the two populations live amicably, the presence of the refugees in Lebanon puts undue pressure on the limited facilities available in Lebanon such as health-care system and economy, housing, education system and other social amenities. This transforms from Syrian Refugees Crisis to Lebanese–Syrian Crisis. The foreign aid cannot effectively address the humanitarian crisis and thus there is need for a substantial solution (Refaat and Mohanna, 2013, P.763). The authors of this article recommend solutions that can help address the crisis. One of them is the Lebanon Government to implement a complete emergency plan to address the social, health, education, economic (Refaat and Mohanna, 2013, P.763). The other solution according to solution Refaat and Mohanna (2013) is putting in place an emergency plan to tackle political instability and insecurity during resettlement (p.173).

In this article, Long highlights that refugee protection and resettlement is a global humanitarian crisis (2013). The movement of people across boundaries by immigration and seeking asylum complicates the matter because it is not easy to keep separate refugee and immigrant schemes (Long, 2013). Most host countries prohibit refugees from accessing employment. Most countries restrict movement of refugees both legally and physically to prevent refugees from mixing and interacting with the local communities. As a result of this discrimination and poverty, the refugees cannot fully enjoy their socioeconomic rights and are thus excluded from labor markets. As a result, refugees suffer from abject deskilling and unemployment (Long, 2013). As a solution, Long suggests that national immigration and protection laws that prohibit the movement and employment of refugees will need to be restructured and reformed. Secondly, Long recommends that host countries need to implement effective and ethical labor migration laws for refugees (2013).

In this study, the author claims that insurrections in Syria have been on the rise over the past few years (Özden, 2013). The result of the political uprising is massive exodus from Syria to neighboring countries. Most of the refugees are running away from violence and psychological turmoil and hence many migrate to other countries to seek for asylum. The refugee crisis in Syria is worsening sharply and its effects are being felt not only in Syria neighbors but across Europe (Özden, 2013). Syria's crisis can blamed for alarming rate of displacement in the region and the consequential humanitarian crisis. Given the crisis has no sign of dwindling anytime soon, the projected number of Syrians fleeing their country to seek refuge will only increase. With the influx of large numbers of Syrians into neighboring countries such as Turkey, discrimination has skyrocketed. The security of Turkey has deteriorated over the course of time as a result of refugee's presence in the country (Özden, 2013).

The Syrian refugee crisis has protracted contrary to the expectations causing anti-migrant sentiments to sprang up. This problem is not only in Turkey but all over the world. One of the solutions İçduygu proposes is adopting policies for socio-cultural and labor market integration (İçduygu, 2013). Another solution is helping the hosting countries such as turkey expand its facilities and social amenities so that they can incase their absorption capacity. The last strategy proposed in this article is for NGOs and global entities should prepare for more refugee floes and arrange to share the burden of the eventual refugee flow (İçduygu, 2013).
